Files should be titled with the author's last name in latin letters (for example: Karpova\_tzy.doc, Karpova\_zayavka.doc, Karpova\_kvytansiya.doc), packaged in the archive (Karpova.zip).

#### ABSTRACTS REQUIREMENTS

1. **The abstracts are limited to 3–5 pages** (A-4 format in text editor WORD / OFFICE, size 14, Times New Roman font, single interval, paragraph indent 1.25 cm (please do not create a paragraph indent using the Tab or Space); margins (top, bottom, left, right) - 2 cm, the text should be printed without spacings with justified alignment, the pages should not be numbered.

#### *Abstract components sequence:*

- *the thematic area corresponding to the subject of the thesis is indicated in the upper right corner;*
- *the upper left corner should include UDC (the indication of the Universal Decimal Classification is mandatory);*

- the title of the abstract should be printed in uppercase letters, bold and center-aligned;
- author's initials and surname are indicated under the title of the abstract, in bold and center-aligned;
- educational institution (place of work / study), e-mail address;
- the text of the abstract is printed with justified alignment;
- the abstract should include the list of references right after the main text, references should be presented in the order of their mention within the abstract, titled "References";
- The list of references in abstract should be arranged in accordance to the National Standard of Ukraine DSTU 8302: 2015 "Information and documentation. Bibliographic link. General terms and conditions of assembly";
- references within the text of the abstract are indicated by square brackets identifying the sequence number of the source on the list and corresponding page number separated with comma, for example: [5, p. 57–61].

**The abstract's components should be formulated in the following order: relevance; presentation of the main research material; conclusions; literature.**

The text should be carefully considered and verified by the author and/ or the scientific supervisor. The editorial board reserves the right to make partial editing in case of the above mentioned requirements violation.

The author is responsible for the content and uniqueness of the submitted abstract.
