Memorandum of Understanding


The provisions recorded below establish the principles and conditions by which The National University of Ostroh Academy and The University of Beira Interior agree to cooperate in academic exchanges, joint programme development, project implementations and student and staff exchange. Such a co-operative agreement will be progressed according to the following clauses:

I. Legal Framework of Both Universities

The National University of Ostroh Academy (NUOA) and The University of Beira Interior (UBI) may, in accordance with their respective policies and procedures, initiate agreements to enhance international good will and understanding and to further contribute to the achievement of their goals and objectives.

II. The National University of Ostroh Academy and The University of Beira Interior - Interests and Objectives

As higher education institutions with complementary missions, The National University of Ostroh Academy and The University of Beira Interior share interests and objectives in student exchange and joint programme development matters. Both institutions are interested in establishing academic co-operation with institutions of a similar nature in order to assist in the achievement of their goals and objectives in such matters.



III. Purpose of the Agreement

The National University of Ostroh Academy and The University of Beira Interior jointly agree to subscribe to a co-operative relationship in order to promote the following activities between both universities:

- a) Development and implementation of joint projects in common areas of interest;
- b) Exchange of teaching and research personnel as per separate detailed agreements;
- c) Exchange of students;
- d) Development in research activities;
- e) Exploration of collaboration at course level, for example articulation arrangements;
- f) Any other activity of mutual interest.

IV. Execution of the Agreement

Any arrangements entered into further to this memorandum will be governed by specific, individual agreements after due approval processes have been followed. All agreements will be signed between the relevant authority of The National University of Ostroh Academy and The University of Beira Interior.

V. Specific Agreements


The specific agreements between both organizations will detail arrangements including financial considerations, term of validity and administrative, operational and quality assurance responsibilities within each institution.

VI. Term and Termination

This agreement will be effective on the date it has been signed by both parties, and it will be in effect for a period of 3 years. The agreement can be renewed for additional 3 year periods by mutual consent of the parties to the agreement. Both parties reserve the right to terminate this agreement giving written notice three months prior to the proposed termination date.

This Agreement may not be assigned by either Party without the prior written consent of the other Party.


